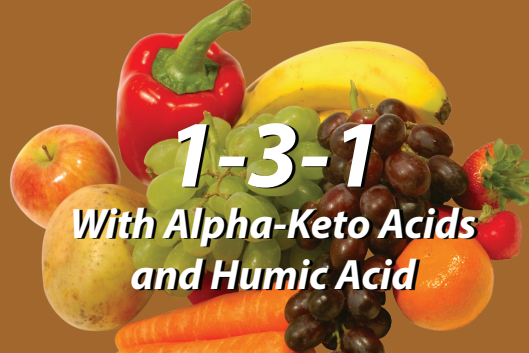

INFORMATION

ByPass contains alpha-keto acids. It is formulated for soil application to fruit trees and vegetables to overcome stress caused by moisture and temperature extremes, and pest related stresses. Timely application of ByPass at recommended rates have shown it to be a valuable asset in combating stresses to fruit trees and vegetables.

COMPATIBILITY

ByPass may be diluted with water. It is recommended that it not be mixed or used in conjunction with herbicides. ByPass can be mixed with IronPlex or KeyPlex products for the correction or prevention of micronutrient deficiencies.

DIRECTIONS FOR USE

Soil Application: *Citrus:* Apply 2 to 4 gallons of ByPass per acre to moist soil following spring flush and summer flush. This material may be applied by under-tree irrigation, spray jet, or herbicide boom. Apply 1 to 2 inches of water to the soil immediately following application to carry ByPass into the root zone of the trees. ByPass may also be used for peaches, apples, pecans, avocados, lime, mangoes and other tropical fruits. **Fertigation:** *Tomatoes, peppers, cucumbers, strawberries, squash, eggplant and other vegetables:* Apply 2 quarts per acre of ByPass before bloom initiation, and 2 quarts per acre at full bloom through via drip irrigation systems for best results.
