### INFORMATION

KeyPlex Calcium Plus is a formulation of chelated calcium. It contains alpha-keto acids, which may facilitate utilization of micronutrients, and increase resistance to environmental stress. It also contains humic acid, which may enhance soil micronutrient availability. KeyPlex Calcium Plus is formulated for foliar or drench application to prevent and correct calcium deficiency in plants when used as directed.

### COMPATIBILITY

KeyPlex Calcium Plus may be used in combination with pesticides. However, in unfamiliar mixtures use a "jar compatibility" test.

### DIRECTIONS FOR USE

**FOLIAR APPLICATION:** Use 1 to 2 quarts of KeyPlex Calcium Plus per acre in a minimum of 20 gallons of water with ground spray equipment. Several applications are recommended during the life of the crop, or per season to maintain active calcium levels in the plant. Use 2 to 3 quarts of KeyPlex Calcium Plus per acre per application in a minimum of 50 gallons of water. **DRENCH:** Mix 1 to 2 quarts KeyPlex Calcium Plus per 100 gallons of water and drench into soil for calcium deficiency correction. Several applications may be required.
