INFORMATION

KeyPlex 415 is a formulation of micronutrients most often found deficient in commercial crops and trees. It contains alpha-keto acids, which may facilitate utilization of micronutrients, and increase resistance to environmental stress. KeyPlex 415 is formulated for foliar application or fertigation to prevent and correct micronutrient deficiencies when used as directed. Maintaining proper levels of micronutrients usually results in increased plant vigor and better yields.

COMPATIBILITY

KeyPlex 415, when added to the spray tank water, will lower the water pH, and can be used in combination with pesticides. However, in unfamiliar mixtures use a “jar compatibility” test.

DIRECTIONS FOR USE

FOLIAR APPLICATION: Use 1 to 2 quarts of KeyPlex 415 per acre in a minimum of 20 gallons of water with ground spray equipment.

AERIAL APPLICATION: Use 1 to 2 quarts of KeyPlex 415 per acre in at least 10 gallons of water per acre.

FERTIGATION: Apply 1 to 2 quarts of KeyPlex 415 per acre via drip irrigation.
