Apply ECOTROL® G as band at planting or after planting. Incorporate ECOTROL® G into soil as outlined below.

Surface Cutworms*	2 to 3 inches
Subterranean Cutworms	3 to 6 inches
Root Maggots	3 to 6 inches
Wireworms	4 to 8 inches
Symphylans	3 to 6 inches

*If type of cutworm cannot be identified, mix into soil 4 to 6 inches deep.
